- \checkmark The Article is to be provided in the Word format.
- ✓ The maximum volume of the Article makes 4 pages, including the title, annotation and the list of references.
- \checkmark The annotation and key words are to be presented in the Russian and English languages in the Article.
- ✓ The abstracts containing plagiarism, incorrect loans as well as the Articles with the text originality less than 80% cannot be accepted for printing (not including the list of references).

The text layout

Computer typing parameters

- Sheet of A4;
- Book page layout;
- Times New Roman print;
- The font of the annotation, key words and the list of references is corpus (10);
- The font of the main text as well as table notes, illustrations, schemes and diagrams is mittle (14), the font of footnotes is cicero (12);
- Head margin 2,5 cm, bottom margin 1,5 cm, left margin 2 cm, right margin 2 cm;
- Single line space.
- The name of the file has to correspond to surname and author's initials in Latin transcription.

Annotation (summary)

The annotation is concise characteristic of the Article. The annotation has to be brief, but at the same time substantial. The recommended size is not more than 500 symbols, i.e. 4-5 sentences. The annotation should contain a scientific issue, objectives and the main author's conclusions in a brief form. What is more, scientific novelty of the Article is to be reflected in the annotation.

The annotation cannot contain borrowings (quotes), facts of common knowledge or details. It has to be written in simple, clear language, short sentences in an impersonal form (it is considered, it is investigated, it is measured, it is found out, etc.).

Key words

Key words mean a search key to the Article. The bibliographic database provides keyword searching. Keywords can reflect basic provisions, results and terms. Both separate words and phrases can act as key words. Usually there are 5–10 key words given to the scientific Article.

The list of references

Bibliographic references in the Article are to be given in square brackets according to the numbering in the list of references. The list of references is to be placed at the end of the Article in alphabetical order. The domestic authors go first.

Tables and drawings

All tables are to have footnotes or references. The table is to be located directly after the text where it is mentioned for the first time, or on the following page. All tables are numbered. There is no full stop at the end of the table title. If the table does not belong to the author, then it is necessary to specify a source in the end of the table title in square brackets.

Headings of columns and table lines are to be written with a capital letter in singular, and subtitles of columns - with a lowercase letter if they make one sentence with the heading, or with a capital letter if they have independent meaning. There are no full stops at the end of headings and subtitles of columns and lines. Headings and subtitles of side columns cannot be divided with diagonal lines. Tables have to be typed **as tables only** (Menu Table, Add the table ...)

All illustrations, schemes, diagrams, graphs, etc. in the Article are called drawings which have to have serial number and titles. If the illustration, the scheme, the diagram, the graph, etc. do not belong to the author, then it is necessary to specify a source in the end of their title in square brackets.
